Performance to fund documentary

'Cruise to Murder' dinner theater will help to tell the story of Ohio's first female presidential candidate

VERMILION — An upcoming "inland cruise" will help solve a murder mystery and raise money to highlight a national scandal.

While that sounds ambitious, it is precisely the plan behind the "Cruise to Murder" dinner theater production Feb. 28 at German's Villa.

The performance by Priceless Productions will invite passengers to eat, drink and make murderous while solving the mystery of the evening. Proceeds from the event will go to Eden Valley Productions' newest project, a documentary of Victoria Woodhull, the first woman to run for president of the United States.

Ohio is known as the mother of presidents, counting eight of 45 presidents as Buckeyes. But it also is the birthplace of Hull, who was born in Gallia County in 1838 to a scoundrel.

Woodhull once was the most famous woman in America and has become largely a footnote, often only occasionally mentioned in passing in presidential election years, said Bette Lou Higgins, artistic director of Eden Valley. The theater company is hoping to change that by producing a documentary about Woodhull to coincide with the 100th anniversary this year of the 19th Amendment, granting

women the right to vote.

In her youth Woodhull became a working medium, claiming psychic abilities that were put to use in her family's traveling medicine show.

The ambitious Woodhull eventually married a few times, became part of New York City society, and became a stockbroker with her also-psychic sister. They were tagged the "Bewitched Brokers," and were the first women in the industry, making a small fortune, according to information from the

production company.

The pair then started an intermittently-published newspaper that didn't shy away from controversial topics, including Woodhull's declaration to campaign for the presidency, running against Ulysses S. Grant in 1872.

On election night, Woodhull was in jail, having offended the sensibilities of Anthony Comstock, secretary of the New York Society for the Suppression of Vice. The sisters had published an account of a brutal assault in which the attackers bragged about what they had done, and an account of an extramarital affair of a prominent minister who was the brother of famed abolitionist and author of "Uncle Tom's Cabin," Harriet Beecher Stowe. While ries, Higgins said, Comstock arrested Woodhull on the claim that she was not allowed to publish it. She eventually was freed and exonerated but the scandal damaged her slim prospects.

The year before, she became the first woman to speak before a United States House of Representative committee. While suffragists were pushing to give women voting rights, she argued that women already had the right to vote, according to the 14th and 15th amendments.

Woodhull's campaign fizzled, and she eventually moved to England and remarried again. A pioneer in the women's rights movement, her desire to win the presidency didn't diminish, and she returned to America in the 1890s to float the idea once more.

She never held public office but many of the ideas of her Equal Rights Party, once thought to be absurd, have become considered mainstream, such as suffrage, public housing for the poor and minority representation in Congress. Woodhull died in 1927 seven years after women finally

By press time, the murder mysterv dinner was sold out. But Eden Valley still is soliciting donations to help film a short documentary about Woodhull to use to secure grants for a longer production.

The Elyria-based group produced "Trail Magic: The Grandma Gatewood Story" in 2015 about Emma Gatewood, an Ohio native who was the first woman to hike the entire Appalachian Trail at the age of 67 after raising 11 kids and surviving domestic violence. The documentary went on to win awards and was nominated in 2017 for a regional National Association of Television Arts and Sciences Emmy award.
